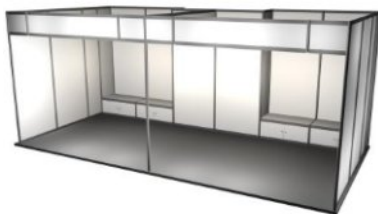

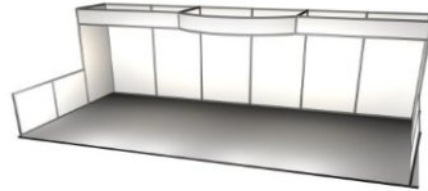

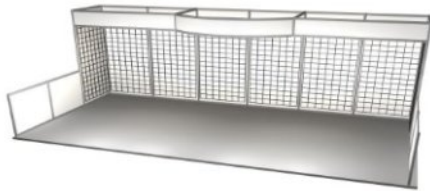
Model B-121 - Slat-Wall

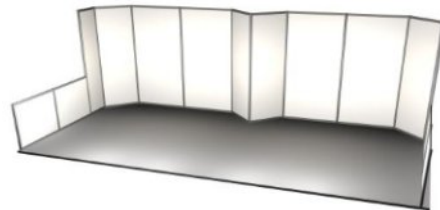
